MARKET COMMENTARY: JANUARY 2023										

Listed equities rallied during the month of January with the Zimbabwe Stock Exchange (ZSE) All Share Index gaining 17.03% to close at 22,813.24 points due to increased liquidity on the market. Similarly, the Top 10 index increased by 19.92% to close at 13,824.24 points. The largest company on the Zimbabwe Stock Exchange (ZSE) by market capitalisation. Delta gained 12,77% during the month under review to close at ZWI 405.79 whilst other beawweights such as Econet and Ecocash gained 61.34% and 39.24% to settle at ZWL135.76 and ZWL51.52 respectively. Furthermore, Hippo and Seedco were among the heavy weights to trade in positive territory, rising by 122.16% and 206.89% to close at ZWL400.00 and ZWL218.20 respectively. Other significant gainers during the month were Dairibord and Tanganda daining 90% and 78,45% to settle at 7WI 59,85 and 7WI 155,25 respectively

On the Victoria Falls Stock Exchange (VFEX), Padenga Holdings and Simbisa gained 26.10% and 28.97% during the month to close at USD0.29 and USD0.43 respectively whilst Seedco International Limited lost 6.68% to close at USD0.28. Caledonia and Nedbank on the other hand, remained unchanged during the month, trading at USD13 and USD11.5 respectively. In the same month Victoria Falls Stock Exchange (VFEX) added one more counter National Foods trading at USD1.81. On the Financial Securities Exchange (Finsec), the lone counter, Old Mutual Zimbabwe Limited remained flat trading at ZWL130 during the month under review

On the fixed income space, interest rates ranged between 30% p.a. and 100% p.a. during the month depending on the investment period. The bank policy rate was reduced to 150% from 200% to align with the inflation outlook. Meanwhile, month on month and year on year inflation slowed down to 1.1% and 229.8% from 2.4% and 243.8% respectively. The Zimbabwean government is targeting to keep monthly inflation between 1-3 percent in 2023, saying it will continue with its tight fiscal and monetary policy measures to keep inflation under control.
