MARKET COMMENTARY:NOVEMBER 2023

Listed equities gained during the month of November with the Zimbabwe Stock Exchange (ZSE) All Share Index gaining 21.76% to close at 191,271.68 points mainly attributable to the gains made by the mid cap counters. Similarly, the Top 10 index increased by 16.90% to close at 82,144.36 points. The Largest company on the Zimbabwe Stock Exchange (ZSE) by market capitalisation, Delta gained 19.38% during the month under review to close at ZWL350,829.57. However, during the month there were significant gainers such as TSL, First Mutual Holdings, Econet, NMB, First Mutual Properties and ZHL gained 112.40%, 70.94%, 46.01%, 64.01%, 53.17% and 60.00%% to settle at ZWL1,100.00, ZWL1,000.00, ZWL730.01, ZWL495.48, 7WI 210 00 and 7WI 160 00 respectively

On the Victoria Falls Stock Exchange (VEEX) Axia Innscor Padenga, SeedCo International and Zimplow gained 58.10%, 6.91%, 16.28%, 20.00% and 9.59%, during the month to close at USD0.08. USD0.45, USD0.17, USD0.20 and USD25.00, respectively whilst Simbisa and Natfoods lost 8.31% and 20.00%, to close at USD0.32 and USD1.20 respectively. Nedbank, West properties Holdings, FCB, Bindura, African Sun and Caledonia on the other hand, remained unchanged during the month, trading at USD12.00, USD10.00, USD0.02, USD0.01, USD0.05 and USD16.20 respectively. On the Financial Securities Exchange (Finsec), the lone counter, Old Mutual Zimbabwe Limited remained unchanged trading at ZWL1,400.00 during the month under review.

On the fixed income space, interest rates ranged between 70% p.a. and 155% p.a. during the month depending on the investment period. Meanwhile, month on month inflation rose to 4.5% from 2.5% in the prior month. Additionally, the annual inflation is estimated at 21.6% from 17.8% the outum for November 2023.
